

Dear Parents/Carers,

Your child has qualified to represent Blackheath Public School at the BMPSSA Zone Swimming Carnival at Glenbrook Swimming Pool, commencing at 9:00 am.

Entry to the pool will cost \$5.10 for all competitors. All children will need to pay as they enter the swim centre. Please ensure your child has the \$5.10 as they will not be allowed to enter without paying. No money will be collected at school. Spectators are more than welcome to attend this year's carnival and will be required to pay a \$2.80 entry fee.

Parents are asked to ensure their child arrives at the pool by 8:45 am for a 9:00 am start. Students may use the pool at 8:30 am to warm-up. The carnival will conclude between 1:30 pm and 2:30 pm. Please report to Mrs Gillian who is the team manager for our school.

There will be a canteen operating but students are encouraged to bring a packed lunch and water bottle. There will be no set lunch break - competitors should eat lunch when a suitable break occurs in their programme. Competitors should also bring sunscreen and something to sit on.

WHAT NOT TO BRING: Please do not allow your child to bring electronic games, mobile phones, chewing gum, jewellery or lollies to the carnival.

Accident insurance information

In the event of injury, no accident or medical insurance cover is provided by the NSW Government Treasury Managed Fund for students participating in school sporting activities, physical education lessons or any other school endorsed activity, unless there is a breach of duty of care by department or school staff. The NSW Department of Education is insured to meet the financial impact of any legal liabilities arising from its activities. It does not provide, nor has it ever provided, accident or medical insurance for students enrolled in government schools.

Concussion management

When a student enrolled in a government school is diagnosed with concussion, the principal must be advised in writing as soon as the diagnosis is confirmed. Students may only return to sport and physical activity once a medical clearance has been provided to the school and, if at a school sport event, to the supervising teacher.

Any student that experiences a suspected concussion during a school endorsed activity, will be removed from the activity and parents/carers will be advised that a medical follow-up is required.

If medical clearance is not provided, the student cannot participate in vigorous or competitive school sport or physical activities for 21 days from the concussion date.
